- Qualifying Membership is open to anyone and allows participation in all programs and benefits except those specified for voting members below.
- Voting Membership is open to editors who have completed at least 500 hours of editorial work (including volunteer work) in the 12 months preceding application for membership. Voting membership allows participation in all programs and benefits. **Additional benefits include eligibility to serve as a member of the national executive council, to serve as a branch chair or treasurer and to vote on national issues at the association's AGM or in a referendum.**  
To apply for voting membership, complete an editing experience form (available at [www.editors.ca/join\\_eac/index.html](http://www.editors.ca/join_eac/index.html)) and submit it with this application. Voting membership is also granted to a member after three consecutive years as a qualifying member.
- Student Membership is open to anyone enrolled in an editing or editing-related postsecondary course or program, or anyone enrolled in full-time postsecondary education. Student members are eligible for all programs and benefits except those specified for voting members above. Student members are not eligible for an ODE profile.  
To apply for student membership, you must supply proof of student status, such as a signed letter from a professor or an unofficial transcript with the name of the educational institution, your name and a date (including the year).
